Registrar (Judicial) (Budget)

May kindly see the online requisition dated 13.01.2022 of Smt. Mita Kumari, the then Special Judge (SC/ST, Prevention of Atrocities Act), Gonda, presently posted as Special Judge (E.C.Act), Mainpuri, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 16382021. In compliance of same, Smt. Mita Kumari furnished all her LL.M. credentials comprising LL.M. Mark-sheets of both the years and copy of Degree for inclusion of her qualification in the service records.

In this context, it is submitted that, earlier an online inclusion note dated 09.03.2022 was submitted before the Hon'ble Mr. Justice Vivek Chaudhary, the then Administrative Judge, Gonda but the note was reverted back to Section dated 31.03.2022 without any orders due to change in the Administrative Judge. Thereafter, as per new order C.L. No. 7/VIII-C-114 Admin (F) dated 29.03.2022, the office note dated 15.04.2022, was placed before Hon'ble Mr. Justice Salil Kumar Rai, new Administrative Judge, Gonda where His Lordships has been pleased to pass the following order dated 30.07.2022:-

"In view of the fact that there has been a long gap, i.e. almost 10 years between the officer having taken admission in LL.M. Course in the University and the date of her degree, her qualification be verified from Kurukshetra University, Kurukshetra and the file be put up after verification. The verification be completed within two months"

In compliance of the orders of Hon'ble the Administrative Judge, Court's letter no. 10769/IV-3122(Admin A-1) dated 29th August, 2022 was sent to the Registrar, Kurukshetra University, Kurukshetra to submit the verification report of LL.M. credentials of Smt Mita Kumari. And, in response of the same, Registrar, Kurukshetra University, Kurukshetra, instead of sending the verification report of the said Judicial Officer, demanded verification fee of Rs. 1500/- (Rs. 500/- per document) vide letter no. AR(CS)/CS-V/2022/01202F dated 19.09.2022.

Thereafter, the office, vide Hon'ble Court's letter no. 14294/IV-3122-Admin(A-1) dated 23rd November, 2022, further queried Registrar, Kurukshetra University, Kurukshetra to furnish the report/information regarding late issuance of final year Mark-sheet and Degree to Smt Mita Kumari along with the University's rule of admissible time-period given to any candidate in submitting the Dissertation.

In response to Court's letter no. 14294/IV-3122-Admin(A-1) dated 23rd November, 2022, Registrar, Kurukshetra University, Kurukshetra, furnished the below mentioned reply of the said query:-

"The candidate Ms. Mita Kumari was earlier issued DMC without Dissertation marks. After that she submitted her Dissertation on 01.01.2021 with penalty of Rs. 36000/- as per rules for submission of Dissertation/Project Report etc. and her Dissertation awards was sent by the Secrecy Branch i.e. on 01.02.2021 to the Result Branch. After receipt of original LL.M.-II DMC and a photocopy of the LL.M.-I, she was issued combined DMC on 05.07.2021 in which her Dissertation marks are mentioned. Thereafter, she was issued Degree dated 31.07.2021.

A copy of rules for submission of Dissertation is enclosed for ready reference and record."

It is pertinent to mention here that Vice Chancellor, Kurukshetra University, Kurukshetra in its Academic Council/Executive Council meeting held on 15.07.2019 regarding submission of Dissertation/Project Report/Mini Project Report/Training Report/Term Paper Report/Field Training Report/Research Work etc. concluded that a penalty will be charged on account of late submission of the above mentioned reports beyond the prescribed dates as laid down in the concerned Ordinances of all UG/PG (Vocational/Professional), Degree/Diploma/Integrated Courses i.e. BA/ B.Sc./ B.Com/ BBA/ B.Voc./ MA/ M.Ed/ M.P.Ed/ MCA/ MBA/ MTM/ M.Tech./ LL.M./ M.Phil etc. And, in the case of Smt Mita Kumari, she has paid a fee of Rs. 36000/- as penalty for collecting her Degree (date of issuance of Degree is 31st July, 2021) after 8 years of completing her LL.M. Part II examination conducted in May'2013 (date of issuance of LL.M. Part-II Mark-sheet is 31st July, 2021).

In this connection, it is submitted that Smt. Mita Kumari, joined the U.P. Judicial Services on 03.01.2004, as Additional Civil Judge (Junior Division), Farrukhabad. Besides, as evident from submitted attested copies of mark-sheet (two years) and degree of LL.M., Smt. Mita Kumari completed two years LL.M. course, and was subsequently awarded degree from Kurukshetra University, Kurukshetra on

31.07.2021 for the examination year 2013, thus said qualification may be included in her service records. It is pertinent to mention here that Admin A-4 section, through offline note, approved by the then Hon'ble Chief Justice dated 26.11.2009 granted permission to concerned Judicial Officer to pursue her two year LL.M. course conducted by Kurukshetra University.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus said qualification of LL.M. Degree may be included in the service records of Smt. Mita Kumari, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 13.01.20222 of Smt. Mita Kumari, Special Judge (E.C.Act), Mainpuri, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri, for kind perusal and order to the effect that a copy of her application along with copy of Mark-sheet (two years) and Degree of LL.M. (uploaded online on 15.01.2022) as well as attested copy of form of U.P. Nyayik Sewa of Smt. Mita Kumari, the then Special Judge (SC/ST, Prevention of Atrocities Act), Gonda, presently posted as Special Judge (E.C.Act), Mainpuri, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
