

## **Joint Registrar (Judicial) Budget**

May kindly see the online application of Sri Tej Pratap Tiwari, District & Sessions Judge, Gorakhpur regarding grant of permission to visit temple of Lord Pashupati Nath in Kathmandu, Nepal during winter vacation i.e. from 25.12.2021 to 31.12.2021.

In his application, Sri Tej Pratap Tiwari has stated that he alongwith his family wishes to pay religious pilgrimage to Lord Pashupati Nath, in Kathmandu, Nepal during winter vacation i.e. from 25.12.2021 to 31.12.2021. He has also submitted required details/declarations necessary for this visit:-

1. That the aforesaid visit is falling during the winter vacation from 25.12.2021 to 31.12.2021 and it is not during any working day of the Hon'ble Court.
2. That no VISA is required for visiting Nepal.
3. That the sole purpose of visit is religious pilgrimage of Lord Pashupati Nath, Kathmandu, Nepal.
4. That The duration of stay in Kathmandu, Nepal would be only during winter vacation that is from 25.12.2021 to 31.12.2021.
5. That the source of expenditure for the stay abroad of the officer and his family would be borne from his salary SBI account no. 20016929796.
6. That by his abroad visit no dilemma is likely to be created before the Government of India or Government of Uttar Pradesh.
7. That no request for abroad visit was submitted or refused to him earlier.
8. That he has not visited any foreign country earlier.

He has, therefore requested for grant of permission to visit Kathmandu, Nepal alongwith his family during winter holidays i.e. from 25.12.2021 to 31.12.2021.

In this connection, it is submitted that in terms of G.O. No.8/12/11/ CX dated 16.3.1971, all Government servants visiting Nepal must take prior permission of the Head of the Department before visiting Nepal and they should enter Nepal territory through some custom check-post and get their luggage cleared by the custom authorities. It is also mentioned in the G.O. that permission to go to Nepal will be given only when Head of the Department is satisfied that the visit of Nepal by the Government servant is necessary and unavoidable. It is also submitted that as per the reports, placed below, no departmental/ vigilance enquiry is pending against Sri Tej Pratap Tiwari. Permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/ departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer wants to visit Kathmandu, Nepal alongwith his family for darshan of Lord Pashupatinath there in winter holidays from 25.12.2021 to 31.12.2021, thus this trip appears to be a religious trip which includes all the days of winter holidays. Now, It is on the discretion of the Hon'ble High Court either to grant him permission or to pass any such order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Vide subsequent order dated 19.10.2020, Hon'ble the Chief Justice has been pleased to nominate Hon'ble Mr. Justice Pritinker Diwaker, to consider request of permission of the Judicial Officers to visit abroad in his place.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Gorakhpur for kind perusal and if His Lordship approves, Sri Tej Pratap Tiwari, District & Sessions Judge, Gorakhpur may be granted permission to visit Kathmandu, Nepal for drashan

of Lord Pashupatinath there in winter holidays from 25th December 2021 to 31st December 2021 alongwith his family, as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 19.10.2020 of Hon'ble the Chief Justice, as mentioned above with the conditions and that he will enter Nepal territory through some custom check-post and get his luggage cleared by Custom Authorities and proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
