May kindly see the online application of Smt. Krishn Lila Yadav, Additional District Judge, Shahjahanpur regarding grant of permission to purchase house no. 1/38, block c, sector 36 Noida, Gautambuddha Nagar, measuring 381 sq. m. and having covered area 439.56 sq. m., as per 'agreement to sale' dated 28.01.2020, along with her sister-in-law (Smt. Pushpa Yadav) as co-purchaser in compliance of Court's order.

In this connection, it is submitted that the officer through her earlier application has submitted information about purchase of house no. 1/38, block c, Sector 36 Noida, Gautambuddha Nagar, measuring 381 sq. m. and having covered area 439.56 sq. m., as per 'agreement to sale' dated 28.01.2020 for Rs. 4,80,09,000/-

The matter was submitted before Hon'ble Mr. Justice Manish Kumar, vide detailed office note dated 23.08.2022 and its subsequent office note dated 16.11.2022. The matter was reverted back with the order dated 23.12.2022 of His Lordship which is as follows:-

"Office is directed to submit report as per the relevant provisions applicable in the present case."

In compliance of the Court's order dated 23.12.2022, it is most humbly submitted that the relevant provisions applicable in the present case is the Rule 24 (1) of U.P. Government Servant's conduct Rule-1956, which is as follows:-

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

The said relevant rule was mentioned in earlier detailed office note dated 23.08.2022 alongwith the other pointwise details as required under Court's C.L. no. 25/ Admin (A) dated 13.07.1998.

Under the facts & circumstances, may, therefore, if approved, the matter may be placed before Hon'ble Mr. Justice Saurabh Shyam Shamsbery, Administrative Judge, Shahjahanpur for disposal of the matters of Judicial Officers, of information/ permission of sale/ purchase of movable/ immovable property or gift etc., for the District Shahjahanpur for His Lordship's kind perusal in compliance of His Lordship's order dated 23.12.2022 & if approved by His Lordship, Smt. Krishn Lila Yadav, Additional District Judge, Shahjahanpur may be granted permission to purchase house no. 1/38, block c, Sector 36 Noida, Gautambuddha Nagar, measuring 381 sq. m. and having covered area 439.56 sq. m., along with her sister-in-law (Smt. Pushpa Yadav) as co-purchaser from M/s Pinakin impex(p) Ltd. through its authorised signatory Mr. Anil Kumar S/o Late Sri PS Gupta R/o A-24, B Block, Durga chamber, Rajnagar, Distt. Centre, Ghaziabad for Rs. 4,80,09,000/-, in which her share/ payment share is half, as requested, in terms of Rule 24 (1) of U.P. Government Servant's Conduct Rule-1956, as already proposed in earlier detailed office note dated 23.08.2022, subject to the condition

that the relevant papers of the transaction alongwith copy of the sale deed be furnished by her immediately on completion of the transaction?
