May kindly see the letter dated 21.12.2021 (uploaded online on 21.12.2021) of Sri Arun Singh, the then Judicial Magistrate, Shamli at Kairana, presently posted as Civil Judge (Junior Division), Duddhi-Sonbhadra, requesting for sanction of three advance increments vide Case Id 16572021 (Old Case Id 2745). In compliance of same, Sri Arun Singh furnished all his LL.M. credentials comprising LL.M. mark-sheets of all the four semesters and copy of Degree. It it pertinent to mention here that initially Sri Arun Singh has applied for inclusion of degree vide case id 13472021 dated 24.09.2021 which the office has later asked him to withdraw so that his matter could be taken up from single case id which is 16572021.

In this connection, it is submitted that Sri Arun Singh joined the U.P. Judicial Service on 15.11.2019, as Judicial Magistrate, Shamli at Kairana. Besides, as clear from submitted attested copies of mark-sheet (four semesters) and degree of LL.M. (uploaded online on 21.12.2021), Sri Arun Singh completed two years LL.M. course, for the academic session 2016-2018, and was subsequently awarded degree from Chaudhary Charan Singh University, Meerut on 24.09.2018 for the examination year 2018, thus said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Arun Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 21.12.2021 of Sri Arun Singh, the then Judicial Magistrate, Shamli at Kairana, presently posted as Civil Judge (Junior Division), Duddhi-Sonbhadra, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra, for kind perusal and order to the effect that a copy of his application along with copy of mark-sheet (four semesters) and degree of LL.M. (uploaded online on 21.12.2021) as well as attested copy of form of U.P. Nyayik Sewa of Sri Arun Singh, the then Judicial Magistrate, Shamli at Kairana, presently posted as Civil Judge (Junior Division), Duddhi-Sonbhadra, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
