A/c (copy of statement of A/c can be seen as attachment) It is pertinent to mention here that the first payment was made as booking amount via cheque no. 506640 dated 03.02.2020 to Tirupati Vehicle Pvt. Ltd, Bijnor and the rest 1,40,000/- was paid through another cheque no. 437087 dated 10.02.2020 to Tirupati Vehicle Pvt. Ltd, Bijnor from her State Bank of India Account No. 20197881073. From the above-mentioned down payment, an amount of Rs. 40,000/- was contributed as gift out of love and affection by her father (non-returnable) and whereas Rs. 50,000/- (Rs. 35000/- and Rs. 15000/respectively from two people) was taken from friends, which has been returned in later two month from the date of purchase and the rest Rs. 60,000/- was paid by her from her salary of February, 2020. The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Bijnor also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P.
