May kindly see the online application of Sri Rajiv Kumar Vats, Additional District Judge (FTC), Gautambuddha Nagar who, joined service on 18.03.2020, drawing gross salary of Rs. 1,55,957/- & take home salary of Rs. 1,40,577/- regarding information about purchase of a new Kia Seltos G 1.5 6MT HTK Plus car allotted reg. no. UP17DU2333, intimated through application dated 25.12.2021.

Through his application, Sri Rajiv Kumar Vats has submitted information about purchase of new car on 06.11.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Mahelka Motors Pvt. Ltd., Opp. Partapur Police Station, Delhi Road, Meerut (U.P.) who is an authorized dealer, for Rs. 13,60,644/- in total (copy of 'sale invoice can be seen as attachment), source of money of which is that Rs. 11,23,000/- has been taken as loan from PNB, repayable in 60 EMIs of Rs. 23,000/- (Earlier, a seven year term Auto loan of Rs. 11,23,000/- from PNB is stated to have been granted by the bank, with EMI of Rs. 17,335, which is revised by branch for five year term with EMI of Rs. 23,000/-). (copy of 'loan arrangement letter' can be seen as attachment), Rs. 25,000/- as booking amount & Rs. 2,12,644/- are stated to have been paid to the dealer through online mode (copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Gautambuddha Nagar for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956"?
