

Joint Registrar (Judicial)(Budget)

May kindly see the letter dated 02.01.2022 of Sushri Deepika Attri, Judicial Magistrate, Hathras (uploaded online on 02.01.2022), requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 16742022. In compliance of same, Sushri Deepika Attri furnished her LL.M. credentials comprising LL.M mark-sheets of all the semesters and copy of Degree for inclusion of her qualifications in her service records.

In this connection, it is submitted that Sushri Deepika Attri, joined the U.P. Judicial Service on 30.07.2018, as Judicial Magistrate, Hathras. Besides, as clear from submitted attested copies of mark-sheet (two years) and degree of LL.M. (uploaded online on 02.01.2022), Sushri Deepika Attri completed two years LL.M. course, for the academic session 2018-2020, and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 30.09.2021 for the examination year 2020, thus said qualification may be included in her service-records.

It is pertinent to mention here that Admin A-4 section, through online note, digitally approved by the then Hon'ble Chief Justice dated 26.02.2020 granted permission to concerned Judicial Officer to appear before second year examination for the academic year 2019-2020 conducted by Kurukshetra University.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sushri Deepika Attri, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 02.01.2022 of Sushri Deepika Attri, Judicial Magistrate, Hathras, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Hathras, for kind perusal and order to the effect that a copy of her application (uploaded online on 02.01.2022) along with copy of mark-sheet (two years) and degree of LL.M. (uploaded online on 02.01.2022) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Deepika Attri, Judicial Magistrate, Hathras, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
