May kindly see the online application of Sri Avanish Kumar Pandey, Additional District & Sessions Judge, Mathura who joined service on 16.05.2009, drawing gross salary of Rs. 1,88,463/- & take home salary of Rs. 1,36,388/- regarding information about purchase of a new 'Creta 1.5 CRDI MT Sx (Sc)' car, bearing Chassis number MALPC813LMM253842, intimated through application dated 03.01.2022.

Through his application, Sri Avanish Kumar Pandey has submitted information about purchase of a new car, purchased on 06.12.2021; by giving pointwise details as per Hon'ble Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from MB Auto Wheels Pvt. Ltd. (2020-2021) Auto Zone, Plot no. 623, Gulhariya, Maharajganj road, Gorakhpur, U.P. for Rs. 17,35,000/- including registration and insurance (copy of tax-invoice can be seen as attachment). The source of money, as stated by the officer is Rs. 15,09,000/- has been taken as loan from State bank of India, Branch-Basahartapur, Gorakhpur; repayable in 84 EMIs of Rs. 23,220/- (copy of 'loan sanction/ arrangement letter' can be seen as attachment), Rs 1,85,000/- and Rs. 21,000/- stated to have been paid through cheque no. 423962 and 423958 respectively from his salary savings bank account (copy of statement of A/c with all the entries can be seen as attachment) and Rs. 20,000/- has been got as exchange value of his old Santro car (Exchange related paper can be seen as attachment), which appears to be adjusted in the cost price of the car. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Mathura, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
