May kindly see the online application of Talewar Singh, Additional District Judge, Bijnor regarding information about purchase of Plot no. A-58, Site-C, Zeta-2, Surajpur, Greater Noida, GB Nagar, measuring 300 sq. meters from U.P.S.I.D.C., Kasna, Greater Noida, GB Nagar in his name alongwith his wife name Smt. Alka Singh. In the application, Sri Talewar Singh has stated that he has purchased Plot no. A-58, Site-C, Zeta-2, Surajpur, Greater Noida, GB Nagar, measuring 300 sq. meters from U.P.S.I.D.C., Kasna, Greater Noida, GB Nagar in his name alongwith his wife name Smt. Alka Singh throuh registered lease deed dated 06.12.2018 for 79 years. Earlier, the plot was alloted by UPSIDC to one Sri Vikas Kumar, S/o Sri Rajan Kumar, R/o G-83, Preet Vihar, New Delhi, but later on, Sri Vikas Kumar has returned the plot to UPSIDC and by permission of UPSIDC, the plot has been allotted to himself and his wife's name by UPSIDC and the sale deed i.e. lease deed of the plot has directly executed by UPSIDC in their names. For allotment change and plot transfer, an 'Agreement deed' had been executed between them and previous alottee Sri Vikas Kumar (Attachment- Annexure A) and a sum of Rs. 27,98,000/- had been paid to Sri Vikas Kumar for the plot with market rate premium. As per the said agreement, UPSIDC has changed the allotment of the plot into the name of Sri Talewar Singh and his wife Smt. Alka Singh instead of earlier allottee Sri Vikas Kumar by "Permission for transfer letter dated 20.11.2018 (Attachment- Annexure B), transfer levy for which is payable to UPSIDC @ Rs. 1630/- per sq meter. Thereafter, by paying such due payments, he has got executed Lease deed of the plot directly from UPSIDC. He has also submitted pointwise details of the transaction, as required under the provisions of this Court's Circular Letter No. 25/ Admin (A) dated 13.07.1998 regarding information about purchase of the plot.

	Details of source of amount	Rs. 1,98,000/- paid to the previous allottee through cheque no. 110943, SBI from his salary savings. Rs. 15,00,000/-, Rs. 9,00,000/- and Rs. 2,00,000/- paid throuh RTGS, cheque no. 000262 & cheque no. 000263 from bank home loans and personal loan amounts. Rs.5,37,000/- for transfer levy paid to UPSIDC and Rs. 3,99,000/- for stamp duty paid from his ICICI bank account no. 126601506426. Note: The source of money in officer's account is salary savings and his wife has also sold gold ornaments of Rs. 3,17,429/- on 20.10.2018 (Attachment- Annexure I), amount of which is credited into her account of UBI. All the transfer of amounts is shown by the officer in supporting papers in attachmets. He has also submitted that he has spent a total of Rs. 37,34,000/- against this purcahse which includes premium amount paid to previous allottee, however, in lease deed UPSIDC mentioned the lease sum paid as Rs. 9,05,475/- only which is the said sum already paid by previous allottee to UPSIDC against the previous allotment.	

Under the facts & details mentioned above and as the officer has purchased the plot from a regular & reputed dealer/ Government organization i.e. UPSIDC, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vikas Varma, Administrative Judge, Bijnor, also nominated for "Disposal of the matters of Judicial Officers, of information/ permission of sale/ purchase of movable/ immovable property or gift etc., for the District Bijnor, for His Lordship's kind perusal and information under Rule 24 (1) U.P.
