May kindly see the online requisition dated 06.01.2022 of Sri Mayank Tripathi, Additional District & Sessions Judge, Lucknow, requesting for sanction of three advance increments vide Case Id No. 16902022. In compliance of same, Mayank Tripathi furnished only pass provisional slip and his taking charge certificate for sanction of three advance increments.

Thereafter, an online objection, dated 06.01.2022, was raised by the office of the Court asking him to furnish the attested (not self attested/unattested) copies of mark-sheets of all the semesters/years and copy of Degree, because pass provisional slip is neither admissible for inclusion of qualification nor for sanction of three advance increments. Apart from that, he was also asked modify his application and reapply vide same case Id with the change in prayer from sanction of three advance increments to inclusion of qualification in service records.

In continuation of the above mentioned objection, Sri Mayank, dated 08.03.2022, furnished the attested copies of LL.M. Mark-sheets of first and second year. Thereafter, another objection, dated 09.03.2022, was raised by the office asking him to clarify the reason behind the same examination month of First year and Second year LL.M. In response to the said query, Sri Mayank, dated 03.04.2022, informed the office that since he could not clear the examination in two subjects of First year. He re-appeared for the said examination along with LL.M. second year examination, that is why the examination month mentioned in the mark-sheets of first year and second year result is same. Besides that, Sri Mayank also submitted online application (on portal page) with prayer for inclusion of his qualification in his service records but did not provide the attested copy of Degree.

It is further submitted that, another objection, dated 18.04.2022, was raised by the office asking Sri Mayank to submit the attested copy of Degree for the process of inclusion of qualification in his service records. In response to the same, Sri Mayank, dated 25.04.2022, provided the attested copy of Degree of LL.M. It is pertinent to mention here that Sri Mayank vide letter dated 04.12.2019, bearing endorsement no. 4402/XVP.F./dated 04.12.2019 forwarded by District Judge, Luckonw applied for grant of permission to appear before the second year LL.M. examination through distance learning mode. The concerned Section vide letter no. 1272/IV-4679/Admin (A-4) dated 23.01.2020 granted permission to appear before the said examination.

In this connection, it is submitted that Sri Mayank Tripathi, joined the U.P. Higher Judicial Service on 06.08.2019, as Additional District & Sessions Judge, Lucknow. Besides, as evident from submitted attested copies of Mark-sheets (both the years) and Degree of LL.M., Sri Mayank Tripathi completed two years LL.M. course, for the academic session 2018-2020, and was subsequently awarded Degree from Kurukshetra University on 31.03.2022 for the examination year 2020, thus said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Mayank Tripathi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 06.01.2022 of Sri Mayank Tripathi, Additional District & Sessions Judge, Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (two years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Mayank Tripathi, Additional District & Sessions Judge, Lucknow, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
