May kindly see the letter dated 05.01.2022 of Sushri Kumud Upadhyay, the then Additional Chief Judicial Magistrate, Ambedkar Nagar at Akbarpur (uploaded online on 07.01.2022), presently posted as Civil Judge (Senior Division), Hathras, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 16972022. In view of the above, Sushri Kumud Upadhyay furnished her LL.M. credentials comprising LL.M mark-sheets of all the semesters and copy of Degree Certificate for inclusion of her qualifications in her service records.

In this connection, it is submitted that Sushri Kumud Upadhyay, joined the U.P. Judicial Service on 13.01.2017, as Additional Civil Judge (Junior Division), Varanasi. Besides, as clear from submitted attested copies of mark-sheet (two years) and degree of LL.M. (uploaded online on 07.01.2022), Sushri Kumud Upadhyay completed two years LL.M. course, for the academic session 2018-2020, and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 30.09.2021 for the examination year 2020, thus said qualification may be included in her service-records.

Further, on perusal of her LL.M. documents submitted online, the following observation was made by Hon'ble Administrative Judge, Hathras vide His Lordship's orders dated 18.10.2023, in the following terms: *"The officer has obtained the LL.M. degree after joining the Judicial Services. Whether she had obtained permission for undergoing the said LL.M. course is not available on record. Therefore, same may be asked from the concerned officer."*

In compliance of the above, this office raised an objection dated 19.10.2023 asking the concerned Judicial officer to furnish the copy of aforesaid permission letter & in reply thereto, she has furnished the copy of permission letter no. 18134/IV- 4282/(Admin A-4) dated 19.12.2018 obtained from this Court for pursuing the aforesaid LL.M Degree course, hereon this portal by attachment dated 20.10.2023.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the qualification of LL.M. Degree may be included in the service records of Sushri Kumud Upadhyay, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 05.01.2022 of Sushri Kumud Upadhyay, Civil Judge (Senior Division), Hathras, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras for His Lordship's kind perusal and order to the effect that a copy of her application (uploaded online on 07.01.2022) along with copy of mark-sheet (two years) and degree of LL.M. (uploaded online on 07.01.2022) as well as attested copy of form of U.P. Nyayik Sewa of Sushri Kumud Upadhyay, Civil Judge (Senior Division), Hathras, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in the instant matter ?
