May kindly see the letter dated 08.01.2022 (received online) of Sushri Ganga Sharma, Civil Judge (Junior Division), Ghazipur requesting for inclusion of her Ph.D. Degree in her service records vide Case Id. No. 17052022.

In this connection, it is submitted that Sushri Ganga Sharma, aforesaid, joined U.P. Judicial Services on 26.07.2018 as Additional Civil Judge (Junior Division), Ghazipur. Besides, as evident from her submitted attested copy of her degree of Ph.D., Sushri Ganga Sharma was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Law for the topic "Trade Policy and Law with Reference to Anti-Dumping Measures: Practices and Prospects in India" in the year 2018 from Banaras Hindu University, Varanasi and was issued Degree on 08.09.2018. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P. Nyayik Sewa/UPHJS, thus said qualification is required to be included in the service records.

It is pertinent to mention here that Admin A-4 section, through offline note, approved by the then Hon'ble Chief Justice dated 02.11.2018 and vide Hon'ble Court's letter no. 16123/IV-4607/Admin A-4 dated 02.11.2018 granted permission to concerned Judicial Officer to appear in viva-voce of the Ph.D. course conducted by Banaras Hindu University, Varanasi.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P. ,thus said qualification of Ph.D. Degree may be included in service-records of Sushri Ganga Sharma, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 08.01.2022 (received online) of Sushri Ganga Sharma, Civil Judge (Junior Division), Ghazipur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Ghazipur, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 08.01.2022 (received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sushri Ganga Sharma, Civil Judge (Junior Division), Ghazipur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
