May kindly see online application dated 12.01.2022 of Sri Nitendra Kumar, Additional District Judge, Jhansi, regarding grant of personal pay under voluntary family planning programme in terms of G.O. No. Pa.Ka. 4601/16-11-79-9/155/79, dated 23.02.1980.

It may be recalled that vide this office's response dated 14.02.2022, an objection was found due to the difference between the name of his only child on his birth certificate, submitted herewith this application, in attachment dated 12.01.2022, under heading 'Birth Certificate of My Son', i.e. 'Aksh', and the name, depicted in declaration, submitted in page no.1 as attachment dated 12.01.22, under heading 'Declaration Letters', i.e. 'Aksha Shaurya, and therefore, Sri Nitendra Kumar, aforesaid was asked to remove the same.

Now, vide attachment dated 07.03.2022, Sri Nitendra Kumar, aforesaid, has submitted the required declaration afresh, under heading 'Declaration' in its page no.01, which, bears the name of his child as 'Aksh', similar to the name depicted on the respective birth certificate and thereby removing the objection raised on 14.02.2022.

According to papers attached by Sri Nitendra Kumar, aforesaid through aforementioned online application dated 12.01.2022, details are as under:

1. His date of birth is 25.12.1977.
2. He is 44 years old as per his declaration dated 04.03.2022 as available in the attachment dated 07.03.2022, under heading 'Declaration' alongwith annexures' at page no.03.
3. He joined the service on 14.06.2006 as per his service details.
4. He has only one child as per his declaration dated 04.03.2022 as available in the attachment dated 07.03.2022, under heading 'Declaration' alongwith annexures' at page no.03.
5. The date of birth of his only child, 'Sri Aksh', is 23.02.2009 as per the Birth Certificate, issued by Department of Nagar Nigam, Allahabad, as available in the attachment no.02 under heading 'Birth Certificate'.
6. He has not got the benefit of personal pay under voluntary family planning programme vide declaration dated 04.03.2022 as available in the attachment dated 07.03.2022, under heading 'Declaration' annexures' at page no.01.
7. His wife is alive. She is not a Government Servant and not availing the benefit of personal pay as per the declaration as available in the attachment dated 07.03.2022, under heading 'Declaration' at page no.03.
8. Neither any departmental enquiry is pending against Sri Nitendra Kumar, Additional District Judge, Jhansi, nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer(Confidential-A Section) and information received from Office of Special Officer(Vigilance), Registrar (Judicial)(Enquiry) & Registrar (Judicial)(Enquiry Vigilance) in offline mode.

In terms of G.O. No. Pa.Ka. 1683/16-11-80-9/155/79 dated 26.05.1980 and G.O. No. Pa.Ka. 2667/16-11-80-9/156/78 dated 11.06.1980 required declarations have been furnished by Sri Nitendra Kumar and same are available in the attachment dated 07.03.2022, under heading 'Declaration' at page no.01 & 03.

In this connection, it is submitted that the benefit of personal pay under voluntary family planning programme equal to one increment has been stopped by U.P. Government vide Office Memorandum. No. 2/2019/G-1-37/10-2019 dated 22.08.2019 with immediate effect, however, vide letter no. 2459/Ve. Pa. Pr./Misc./Finanace-2019-20 dated 30.08.2019 of Addl. Director, Directorate of Treasury, Camp Office, Kutchehry Road, Prayagraj, it has been clarified that the said benefit will be given upto 21.08.2019 at the earlier rate. As such, it seems that the officer is entitled to get the benefit w.e.f. his date of admissibility upto 21.08.2019.

Thus, it is submitted that Sri Nitendra Kumar, Additional District Judge, Jhansi has fulfilled all the conditions as laid down in the aforesaid G.O.s for sanctioning of personal pay under voluntary family planning programme. Therefore, he is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment as fixed vide G.O. No. 650/II-4-2013-9Ja/2012 dated 02.07.2013 read with G.O. No. 06/II-4-2018-9 Ja/2012 dated 04.01.2018 and G.O. No. 5097/Ve. Pa. Pra./Vividh/Nyayik/2016 dated 26.02.2018 as amended from time to time, with effect from date of his joining in service (i.e. 14.06.2006) or from the date when he attained the age of 40 years (i.e. 25.12.2017) or from the date when his only child, 'Sri Aksh', attained the age of ten years(i.e. 23.02.2019), whichever is later on. Therefore, he is eligible to get the benefit of personal pay under voluntary family planning programmed w.e.f. 23.02.2019 upto 21.08.2019.

Under the facts and circumstances mentioned above, if deems fit and proper, the file may kindly be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Nominated Judge for 'Sanction of Personal Pay under Voluntary Family Planning Programme to the Judicial Officers' for the district 'Jhansi', for His Lordship's kind perusal and order to the effect that personal pay under voluntary family planning programme equal to one increment or as fixed vide G.O. No. 650/II-4-2013-9Ja/2012 dated 02.07.2013 read with G.O. No. 06/II-4-2018-9 Ja/2012 dated 04.01.2018, G.O. No. 5097/Ve. Pa. Pra./Vividh/Nyayik/2016 dated 26.02.2018 and G.O. No. 2/2019/G-1-37/10-2019 dated 22.08.2019 as amended from time to time, w.e.f. 23.02.2019, when his only child, Sri Aksh, attained the age of ten years, upto 21.08.2019, be sanctioned to Sri Nitendra Kumar, Additional District & Sessions Judge, Jhansi, and His Lordship may also be requested to sign below placed draft sanction order, being placed as attachment?
