May kindly see the online application of Sri Devendra Nath Singh, Additional Principal Judge, Family Court, Lucknow regarding information about sale of old Bullet motorcycle, intimated through his application dated 28.01.2022.

Through his application, Sri Devendra Nath Singh has stated that he has purchased the vehicle no. UP 32 LM 7318 (Bullet motorcycle) on 08.07.2020 which has been duly intimated to this Hon'ble Court on 17.08.2020. But since the said vehicle was not in use for a long time, he has decided to sell it off. Thus, on 18.01.2022, he has sold his motorcycle to Sri Amardeep Singh Vadra S/o Sri Brijendra Singh Vadra R/o 551K/244 Bhilawa, Chandan Nagar, Alambagh, Lucknow for Rs. 1,25,000/- through P.R. Riders Pvt. Ltd., Sapru Marg, Lucknow. The sale price of the said vehicle i.e. Rs. 1,25,000/- is stated to have been transferred by Sri Amardeep Singh Vadra's A/c to the officer's A/c (copy of passbook can be seen as attachment). The purchaser is neither related to him in any manner nor any of his case is decided or pending in his Court. (Copy of sale letter, RC & certificate can be seen as attachment). The officer has therefore, intimated about the sale of his old motorcycle for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer has purchased the motorcycle in the year 2020 (intimation has been duly submitted by the officer through Case ID no. 0558). His date of joining the judicial service is on 16.06.2006. Thus, he has sold the motorcycle through a regular and reputed dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority; Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Lucknow, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
