May kindly see the online requisition dated 09.02.2022, raised vide Case Id S00017582022, of Sri Brahmpal Singh, Civil Judge (Senior Division), Rampur, requesting for inclusion of degree of Doctor of Philosophy (Ph.D) in Law in his service-records.

In this context it is submitted that on perusal of initially attached credentials, certain discrepancies were noticed and thus objection was imposed accordingly on 21.02.2022. Subsequently, on 25.02.2022 Sri Brahmpal Singh, aforesaid has furnished sought documents, after completion of necessary formalities.

Vide instant request, Sri Brahmpal Singh has informed this Court that prior to entering in U.P.Nyayik Sewa he was pursuing Ph.D in Law from Lucknow University and submitted his thesis based on the topic - Parliamentary Privilege in India, after obtaining proper permission, granted vide Court's letter no. 4190/IV-4409/Admin (A-4) dated 09.04.2019. He has further informed that he has been awarded the degree of Ph.D in Law from Lucknow University on 26.11.2021 and now wishes the same to be included in his service- records. In support of instant request, Sri Brahmpal Singh has furnished attested copy of degree (**attachment under heading "Attested Ph.D. Degree"**).

In this context it is submitted that from perusal of Ph.D. credentials attached herewith as well as relevant records available in Misc. file of Sri Brahmpal Singh, aforesaid, it is evident that he was granted permission to submit his thesis in pursuance of Ph.D. in Law, vide Hon'ble Court's letter no. 4189/IV-4409/Admin (A-4) dated 09.04.2019 and was subsequently awarded degree of Doctor of Philosophy (Ph.D) in Law from Lucknow University on 26.11.2021. It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of Ph.D. in Law may be included in the service records of Sri Brahmpal Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 09.02.2022 of Sri Brahmpal Singh, Civil Judge (Senior Division), Rampur, may be sent to the Government of U.P. for obtaining necessary orders.

In the view of above submissions, if approved, instant matter may kindly be placed before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Rampur, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with attested copy of Degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Brahmpal Singh, Civil Judge (Senior Division), Rampur, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
