May kindly see the online application of Smt. Minakshi Sinha, the then Civil Judge (Senior Division), Firozabad, presently posted Chief Judicial Magistrate, Firozabad who joined service on 04.06.2013, drawing gross salary of Rs. 1,36,031/- & take-home salary of Rs. 1,08,629/- regarding information about purchase of a new Maruti XL6 car, allotted reg. no. UP-70-FL-5317, purchased on 31.10.2021, intimated through application dated 31.01.2022.

Through his application, Smt. Minakshi Sinha has submitted information about purchase of a new Maruti XL6 car on 31.10.2021 for Rs. 11,03,777/- by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Prem Motors Pvt. Ltd., Nehru Nagar, By-Pass Road, Agra, against which 3,00,000/- and Rs. 3,00,000/- are stated to have been paid through cheques nos. 695582 & 695583 dated 01.11.2021 out of her own S.B. A/c no. 20125609579, SBI and sums of Rs. 1,99,000/-, Rs. 1,000/-, Rs. 1,61,527/- & Rs. 10,800/- on 31.10.2021, 01.11.2021 & 02.11.2021 respectively through RTGS/ NEFT (Copy of account statement can be seen as attachment-Statement) are stated to be paid by her husband Sri Vivek Verma, who is posted as Senior Manager (Law), P.N.B., Bareilly, drawing gross & take-home salary of Rs. 1,06,917/- & Rs. 92,666/- respectively. Rs. 1,31,450/- was paid out of cash savings at home of both of them. The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court. Other papers i.e. Invoice of the car and registration certificate are also annexed as attachment.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad for "Disposal of the matters of the Judicial Officers, of information/ permission for sale/ purchase of movable/ immovable property and permission/information to accept gift under U.P. Governments Servants' Conduct Rules 1956" for the district Firozabad, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
