May kindly see the online application of Sri Yadavendra Singh, Spl. Judge (SC/ST, Pev. of Atroci Act), Bulandshahar regarding grant of permission to purchase 0.32 bore Revolver.

In this connection it is submitted that Sri Yadavendra Singh in his earlier application has stated that for some personal security reasons, he needs firearm to avoid any adversity. Hence, he has applied for short gun (Pistol/Revolver) licence before the District administration Bulandshahar bearing application no.8074 on 21-03-2022. He has therefore, requested for grant of permission to purchase the said firearm to this Hon'ble Court. Furthermore, he was sent an objection that he may apply for issuance of firearm licence to the appropriate authority. However, for grant of permission to purchase a firearm, he should have to intimate about the firearm and source of money of its purchase alongwith supporting papers. In reply of which Sri Yadavendra Singh has submitted information regarding purchase of the said firearm & has also submitted supporting papers along with his intimation (Gun licence, Bill and NEFT receipt can be seen as attachment) .

In this connection, it is also submitted that on receipt of information about purchase of a revolver by the officer, it was found that the officer has purchased the firearm i.e. one .32 bore Revolver bearing no. C-221486 "webley Scott" made in India from authorised dealer Capital Gun House, 37/54 Meston Road Kanpur U.P. on 23-10-2022 for Rs. 1,75,000/-. The payment was made in advance through NEFT on 12-10-22 through his S.B. a/c no. 30698302323 SBI Dayalbag Agra. The said firearm has been purchased without obtaining prior permission of this Court, as provided in Court's C.L. No. 11/ Ivh- 16/ Admin (A) dated 12.04.2010, as such again the officer was asked to clarify about the same. Now, in reply of Court's objection, the officer has stated that obeying the above circular, he has applied for permission for purchasing firearm in anticipation of issuance of licence by authority concerned on 24.03.2022. Thereafter some objections were raised on Portal by yourgoodself and were answered by him on Portal itself. Just on submitting the answer to the objection on Portal, the entire correspondance disappeared from portal except his application dated 24.03.2022. Even today he was to see the previous correspondance done in this regard on Portal after all possible efforts to his knowledge. That on issuance of Gun licence in the month of Sept.2022 after lapse of about six months, what he could recollect on memory basis was to furnish the details of purchased weapon whether it is a Pistol or Revolver, name of authourised dealer, Bill and source of amount paid which he furnished earlier in the month of June 2023. Thus unfotunately, unintended and bonafied mistake has been committed on his part due to above reasons for which he has deeply apologized.

As such, the matter is now upto the discretion of Hon'ble Court either to accept the information submitted by the officer, to regularize the matter or to pass any other order, which deem fit and proper.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Bulandshahar for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
