May kindly see the online application dated 15.02.2022 of Dr. Deepak Swaroop Saxena, District & Sessions Judge, Gonda regarding grant of permission to use staff car for undertaking journey to District Ramnagar (Uttarakhand) to attend a family function on 19.02.2022.

In his application, Dr. Deepak Swaroop Saxena has stated that he alongwith his family wants to go to District Ramnagar (Uttarakhand) to attend a family function on 19.02.2022. The distance of Ramnagar from District Head Quarter, Gonda is about 474 Km. He want to use the official car bearing Registration No. UP 43 G 0414 for this journey. He shall pay the charges as per rules. He has, therefore, requested that he may kindly be permitted to use official vehicle No. UP 43 G 0414 for this journey. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for the use of the official vehicle for the above-mentioned visit.

In this connection, it is submitted that as he had applied for the same permission at very short notice and the proposed journey date was passed over, it has been asked from the officer to intimate as to whether he has performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance traveled, challan receipts and if the journey exceeds from 200 kms then intimate about the amount paid. In response, Sri Saxena has replied that he has traveled total distance 1195 Km. in which 995 Km exceeds from the permissible limit of 200 Km. He has deposited Rs. 2985.00 through challan No. BM0052 dated 22.02.2022 (Copy in attachment). In this connection, it is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are authorized to use the official vehicle for 200 kms per month for personal use of the staff car & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. In this way, the journey from Head Quarter to Ramnagar after deducting permitted 200 kms. of one month limit, the distance of remaining 995 Kms., for which the officer has deposited Rs. 2985/- @ Rs. 3/- per km. through challan on 22.02.2022 which has been deposited in SBI, Gonda. Copy of Challan can be seen as attachment.

In this connection, it is submitted that the date for his visit from Head Quarter to is passed over & in the meantime the journey has already been performed by the officer as records shows. He has used the official vehicle for his personal journey from Head Quarter to Ramnagar which is in accordance with Rules & the G.O. and has deposited due money, his request to use the official vehicle may be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and if His Lordship approves, Dr. Deepak Swaroop Saxena, District & Sessions Judge, Gonda be granted ex-post facto permission now, to use official vehicle No. UP 43 G 0414 for the journey performed as mentioned above, as per the provisions of relevant Rules and G.O.?
