It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956:-

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

Rule relating to gift i.e Rule 11 of U.P. Government Servant's Conduct Rules, 1956 is as follows: -

11. Gifts:- A government servant shall not without previous approval of Government:-

(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

In this connection, it is submitted that as the gift money is proposed to given by his mother to him for purchase of the house, who appears to be officer's closest relative, there appears to be nothing objectionable, as per the abovementioned rule.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly, also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district, for His Lordship's kind perusal and, if His Lordship approves, Sri Satya Deo Gupta, Special Judge, SC/ST Act, Bareilly be granted permission to purchase Semi-finished house no. 12A/10, SFS (99/200), Vrindavan Scheme-3, Sector 12 A, Lucknow, measuring constructed area of 99 square meters on the plot area of 200 square meters from Sri Kansu Ram, S/o Sri Seetam Ram, present resident of 21A, Udyan, Pilibhit Bye Pass Road, Mahanagar, Bareilly for Rs. 60,00,000/- (Sixty lac rupees), as requested, subject to the conditions that relevant papers of purchase transaction be submitted by him immediately after its completion?
