May Kindly see the online application of Sushri Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi by which she has requested for grant of ex post facto permission for her appearance in the examination of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) as well as to grant her 'No Objection Certificate' for appearing in the interview of the same..

In her application, Sushri Nikita Sengar has stated that she wishes to appear for interview for Andhra Pradesh Judicial Services Exam scheduled on 3rd March 2022 (notification no.9/2020-RC). She has also stated that previously she had applied for permission to appear in the aforementioned exam (application case Id. 2416) which was approved by the Hon'ble High Court. Thereafter, through online objection, she was asked to clarify the anomaly, found in her application and attachment about the dates of mains examination and also be asked to clarify the reason for not obtaining prior permission for her appearance in the Mains examination. In reply, the officer has stated that due to her mistake, she has made an oversight in taking permission for mains exam and intimating about the same and she has apologised for the same. She has also stated that the mains exam was held on 08.01.2022- 09.01.2022 and due to some network problem the wrong pdf was uploaded. Now she has attached the correct result dated 14.02.2022, which can be seen as attachment. She has, therefore, humbly requested for grant of ex- post facto permission to appear in the aforesaid examinations.

In this connection, it is submitted that the officer has joined Uttar Pradesh Nyayik Sewa on 16.11.2019. It is also pertinent to mention here that the officer has already appeared for the Mains examination of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) examination, held on 08.01.2022-09.01.2022 and passed the same, thus wants to appear in the interview of the same; Now it's upto the discretion of the Hon'ble High Court either to grant her ex-post facto permission for her appearance in the Mains examination to regularize the matter and issue a 'No Objection Certificate' for appearing in the interview of the same examination or to pass any other order which His Lordship deems fit and proper.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi for His Lordship's kind perusal and orders to the effect that ex-post facto permission be granted to Sushri Nikita Sengar, Additional Civil Judge (Junior Division), Hardoi for her appearance in the Mains examination of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) as well as permission to issue 'No Objection Certificate', offline under the signature of Joint Registrar (Judicial) (Budget) in favour of the officer for appearing in the interview of Andhra Pradesh Judiciary 2021 (Notification no. 9/2020-RC) examination, as requested, subject to the conditions mentioned above?

Or

To pass any other order which His Lordship deems fit and proper.
