May kindly see the online requisition dated 26.02.2022 of Sri Hrishikesh Pandey, the then Secretary, DLSA, Saharanpur, presently posted as Additional Civil Judicial Magistrate, Saharanpur, requesting for inclusion of LL.M. Degree in his service records vide Case Id No. 18872022. In compliance of same, Sri Hrishikesh Pandey furnished his LL.M. credentials comprising of Mark-sheets of all the semesters and copy of Degree.

Thereafter, an online objection, dated 02.03.2022, was raised by the office of the Court asking Sri Hrishikesh Pandey to furnish the attested copies of Mark-sheets of all the semesters and copy of Degree. In compliance of same, Sri Hrishikesh Pandey furnished his LL.M. credentials vide dated 03.03.2022. Further, another objection, dated 23.03.2022, was raised by the office asking Sri Hrishikesh Pandey to clarify the ambiguity in the date of issuance and examination month of Marksheets. Sri Hrishikesh Pandey, vide dated 14.04.2022, submitted the reason behind the said query.

In this connection, it is submitted that Sri Hrishikesh Pandey, joined the U.P. Judicial Service on 28.05.2013, as Civil Judge (Junior Division), Siddharth Nagar. Besides, as evident from submitted copies of Mark-sheets (six semesters) and Degree of LL.M., Sri Hrishikesh Pandey completed three years LL.M. course, and was subsequently awarded Degree from University of Delhi, Delhi on 14.03.2014 for the examination year 2013, thus said qualification may be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Hrishikesh Pandey, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 26.02.2022 of Sri Hrishikesh Pandey, Additional Civil Judicial Magistrate, Saharanpur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (six semesters) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Hrishikesh Pandey, Additional Civil Judicial Magistrate, Saharanpur, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
