May kindly see online request dated 07.03.2022 raised via E-services portal accompanied with application dated 06.03.2022 (**attachment under heading Application**), of Ms. Kavya Srivastava, Judicial Magistrate, Sitapur regarding change of home district from Lucknow to Gorakhpur in her service records.

Vide aforesaid request, Ms. Kavya Srivastava has informed that her father was a Government servant and after retirement settled in Lucknow. At the time of joining U.P.Nyayik Sewa, she mentioned Lucknow as her home district for sake of correspondence convenience however as her father's native place is Gorakhpur and her relatives are still residing there thus she wants her home district to be changed from Lucknow to Gorakhpur.

Further, vide affidavit dated 16.02.2022 (**attachment under heading Affidavit regarding Para 31 of Manual of Government Order**) she has sworn that she keeps visiting Gorakhpur frequently for discharge of various domestic and social obligations as her grand father is aged and infirm and permanently resides there. Besides, from perusal of Residence Certificate dated 14.01.2022 (**attachment under heading Residence Certificate**) issued from the office of the Sub-Divisional Magistrate, Gorakhpur it is evident that Ms. Kavya Srivastava, aforesaid is a native of Gram Panchayat-Khajuri Pandeya, Post-Tiha Mohammadpur, Police Station-Badhalganj, Tehsil-Gola, District-Gorakhpur. Thus, vide aforesaid request dated 07.03.2022, Ms. Kavya Srivastava, aforesaid has requested office of the Hon'ble Court to change her home district from Lucknow to Gorakhpur in her service records.

In support of instant request, Ms. Kavya Srivastava has furnished several documents as attachments viz. original affidavit, self-attested copy of Khatauni of agricultural land held in name of her grandfather- Sri Suresh Chandra, copy of residence certificate dated 14.01.2022 issued from the office of Sub-Divisional Magistrate, Gorakhpur, copy of residence certificate dated 06.02.2022 issued by Gram Pradhan, copy of Family Register, etc.

In the view of above submitted facts and circumstances, if approved by Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Sitapur, copy of letter dated 06.03.2022 (**attachment under heading Application**) of Ms. Kavya Srivastava, Judicial Magistrate, Sitapur accompanied with other essentials (**viz. original affidavit, self-attested copy of Khatauni, copy of residence certificate dated 14.01.2022 issued from the office of Sub-Divisional Magistrate, Gorakhpur, copy of residence certificate dated 06.02.2022 issued by Gram Pradhan, copy of Family Register, attested copy of Form of U.P.Nyayik Sewa, etc.**) regarding change of home district from District-Lucknow to Gorakhpur in her service records, may be sent to the Under Secretary, Appointment Section-4, Government of U.P, Lucknow, requesting thereby to obtain necessary orders of the Government in the instant matter ?
