## Joint Registrar (Judicial) (Budget)

May Kindly see the online application of Sushri Shilpa Jain, Civil Judge (Junior Division) (Fast Track Court), Saharanpur by which she has requested for grant of permission to appear in the prelims of Delhi Judicial Services Exam 2022.

In her application, Sushri Shilpa Jain has stated that she wishes to appear in Delhi Judicial Service Examination 2022, Advertisement dated 23.02.2022. She has also stated that Hon'ble High Court of Delhi has invited online applications for 123 seats in Delhi Judicial Service and the examination would be conducted in three stages namely Preliminary Examination, Main (Written) Examination and Viva-Voice. The preliminary examination is scheduled to be conducted on 27th March 2022. She has also enclosed copy of advertisement and copy of her online application form, which can be seen as attachments. She has, therefore, requested for grant of permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 15.11.2019. It is also pertinent to mention here that the instant matter was submitted before Hon'ble Mr. Justice Saral Srivastava, the then Administrative Judge, Saharanpur vide earlier office note dated 09.03.2022 and after change of Hon'ble Administrative Judges list, His Lordship vide order dated 23.05.2022 directed **to redraft the note in compliance of C.L.-7/VIII-C-114/Admin(F) dated 29.03.2022** (Circular regarding nomination of Hon'ble Judges as Administrative Judges w.e.f 01.04.2022). However, the said preliminary examination may be conducted on the scheduled date, but as His Lordship has been pleased to order to redraft the note in compliance of C.L.-7/VIII-C-114/Admin(F) dated 29.03.2022, the same is being redrafted by assuming that the officer could have appeared in the said examination in anticipation of Hon'ble High Court's permission. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.

2. No preferential treatment will be given in the matter of leave, postings and transfer.

3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal, and if His Lordship approves:-

Sushri Shilpa Jain, Civil Judge (Junior Division) (Fast Track Court), Saharanpur be granted ex-post facto permission to appear in the preliminary Examination of Delhi Judicial Services Examination- 2022, as requested?

Or

To pass any other order seeking information about actual appearance of the officer in the aforesaid examination, for taking further necessary action in the matter.
