May Kindly see the online application of Sri Kapil Yadav, Civil Judge (Junior Division), Firozabad by which he has requested for grant of permission to appear in the Mains examination of Haryana Civil Services (Judicial Branch) 2021.

In his letter, Sri Kapil Yadav has stated that he wishes to appear in Mains Examination of Haryana Civil Service (Judicial Branch) 2021, to be held from 15.04.2022 to 17.04.2022. Thereafter, through various online objection, the officer was asked about his appearance in the preliminary examination and mains examination. In reply, of the same, the officer has stated that he had applied for the permission for preliminary examination and stated that by notification dated 30.03.2022, the dates of Mains examination to be held from 15-17 April to 6-8 May. Again as the the same application was received after the stated date of examination, the officer was again asked about his appearance in the examination and in reply, he has stated that the mains examination, again got rescheduled to 20-22 May vide notification dated 10.05.2022 and he has appeared for the mains examination conducted from 20.05.2022 to 22.05.2022. He has also enclosed relating papers, which can be seen as attachments. He has, therefore, requested to the Hon'ble High Court for permission to appear in the Mains of the aforesaid examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 16.12.2019. It is also pertinent to mention here that the officer has applied for grant of permission to appear in the preliminary examination of Haryana Civil Services (Judicial Branch) Examination, 2021 and the same is at the level of Hon'ble Judge. Now, the officer has stated that he has appeared in the mains examination in anticipation of Hon'ble Court's permission, now, it is on discretion of His Lordship either to grant him ex-post facto permission for his appearance in the stated examination or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the Government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved the instant matter be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad for His Lordship's kind perusal and orders to the effect that ex-post facto permission be accorded to Sri Kapil Yadav, Civil Judge (Junior Division), Firozabad for his appearance in the Mains examination of Haryana Civil Services (Judicial Branch) Examination, 2021, as requested, subject to the conditions mentioned above?
