In reply, the officer has stated that due to inadvertent mistake his digitally signed application was uploaded instead of Annexure C i.e. Announcement dated 04.03.2022 by Haryana Public Service Commission regarding tentative dates for MAINS examination". He has deeply regretted for the same and has undertaken that he would be more cautious next time while sending applications and now he has uploaded the required announcement dated 04.03.2022 which can be seen as attachment. In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 13.02.2020. Earlier, vide order dated 10.02.2021 of Hon'ble Administrative Judge, Bulandshahr, he had been accorded permission to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21 for the post of Civil Judge (Jr. Div.). Now, it is desirable that he may be accorded permission to appear in the Mains Examination of the same as he has cleared the preliminary examination, if the Hon'ble Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahr for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana-Bulandshahr to appear in the Mains examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21, as requested, subject to the conditions mentioned above?
