May kindly see the online application dated 12.03.2022 of Dr. Deepak Swaroop Saxena, Principal Judge, Family Court, Bulandshahar regarding grant of permission to use staff car for undertaking personal journey from Head quarter Gonda to Meerut on 13.03.2022 to visit his ailing father.

In his application, Dr. Deepak Swaroop Saxena has stated that he along with his family, wants to go to Meerut to visit his ailing father on 13.03.2022. The distance of Meerut from District headquarter, Gonda is about 693 Km. He wants to use official car bearing Registration No. UP 43 G0414 for this journey. He shall pay the charges as per rules. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid personal journey. It has been further asked from the officer that whether he has performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms then to intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey from Gonda to Meerut in official car bearing reg. no. UP 43 G0414, travelled 1543 kms. and has paid an amount of Rs. 4629/- by challan No. CL00036 on 21.03.2022 which has been deposited in SBI, Gonda. Copy of Challan can be seen as attachment. Furthermore, It has been inquired from him that why he applies for this type of permission just on the same day of journey or just a day before and he performs the journey without the grant of permission/ during pendency of his application, to use official vehicle for personal use. He is also asked to clarify about the point mentioned above, so that the matter may be placed before the Hon'ble Court with certain required details. It is expected that he may apply for this type of permission well in advance so that the matter may be considered for grant of prior permission in this regard by this Hon'ble Court. In reply of the said query, he has stated that the journey was performed all of sudden in anticipation of permission from the Hon'ble Court. He has deposited all the applicable charges as per rules and has requested to accept his sincere apology for inconvenience caused in this regard. Thus, he has requested to place his apology before Hon'ble Court for kind consideration. In future, he will apply this type of permission well in advance. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. He used the official vehicle for his personal journey from Gonda to Meerut and has deposited due money, the same is in accordance with the relevant G.O. As such, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official car bearing Registration No. UP 43 G0414 by Dr. Deepak Swaroop Saxena, Principal Judge, Family Court, Bulandshahar for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
