May kindly see the online application of Sri Subhash Chandra-VIII, Spl. J. (SC/ST, Pev.of Atroci Act) Aligarh, who joined service on 31.05.2001, drawing gross salary of Rs. 1,96,512/- & take home salary of Rs. 1,41,772/- regarding information about purchase of a new Mahendra XUV 700 car, allotted reg. no. UP80GB9669 (Copy of RC can be seen as attachment, intimated through an application dated 31.03.2022.

Through his application, Sri Subhash Chandra has submitted information about purchase of a new car on 09.02.2022 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Atmaram Auto Enterprises, Agra for a total of Rs. 21,60,508/- (Copy of Tax invoice can be seen as attachment), source of money of which is that Rs. 19,90,000/- has been taken as loan from Bank of Baroda, repayable in 84 monthly EMIs of Rs. 30,181/- (copy of 'Bank loan sanction letter' can be seen as attachment), Rs. 21,000/- & Rs.1,00,000/- (from his SBI account no. 30080611241 on 19.1.21 & 09.02.2022 respectively) and Rs. 49,508/- (through Google Pay by his son Aviral Chandraa's SBI bank account no. 35828714777 on 09 February 2022 which already deposited time to time from his SBI account no. 30080611241 for the purpose of purchasing the car (copy of statement of accounts can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court. He has, therefore, submitted desired information alongwith all the relevant papers for kind perusal and information.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about the purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Aligarh, for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
