May kindly see the online application dated 25.03.2022 of Sri Sushil Kumar Rastogi, District & Sessions Judge, Shahjahanpur regarding grant of permission to use staff car for undertaking personal journey from Shahjahanpur to Allahabad for some necessary work on 26.03.2022 after court hours.

In his application, Sri Sushil Kumar Rastogi has stated that he wants to go to Allahabad for some necessary work on 26.03.2022 after court hours. The distance of Allahabad from District headquarter Shahjahanpur is about 400 K.M. To undertake this journey, he desires to use official vehicle no. UP 27 G0521. He will pay the expenses as per rule for use of official vehicle. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. Thereafter, he was asked to intimate as to whether he had performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey on 26.03.2022 from Shahjahanpur to Allahabad in official car bearing reg. no. UP 27 G0521, travelled 814 kms. and has paid an amount of Rs. 2442/- by challan No. CT00055 on 29.03.2022 which has been deposited in SBI, Shahjahanpur. Copy of Challan can be seen as attachment. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. He used the official vehicle for his personal journey from Shahjahanpur to Allahabad and has deposited due money, the same is in accordance with the relevant G.O. As such, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal & if His Lordship's approves, Sri Sushil Kumar Rastogi, District & Sessions Judge, Shahjahanpur be granted ex-post facto permission to use official vehicle no. UP 27 G0521 for his personal journey to Allahabad on 26.03.2022 as mentioned above, as per the provisions of relevant G.O.?
