May kindly see the online application of Sushri Preeti Giri, Civil Judge (Junior Division), Amroha regarding grant of permission to visit Paris and England (Europe) to attend the Convocation ceremony of her real sister Ms. Vineeta Giri, from 12.06.2022 to 19.06.2022.

In her application, Sushri Preeti Giri has stated that she wants to visit Europe to attend the Convocation ceremony of her real sister Ms. Vineeta Giri, who has graduated from ESCP Business School, Paris. She has also stated that she is planning to visit Paris and England during Summer Vacation of 2022, from 12th June, 2022 to 19th June 2022 on this special moment of her life. Thereafter through online objection, the officer was asked to submit declaration as per Hon'ble High Court's C.L dated 27.05.2017 and also be asked to state the source of expenditure of her visit. In reply, the officer has submitted her declarations, which are as follows:-

1. That by abroad visit, no dilemma is likely to create before the Government of India or before Government of Uttar Pradesh.
2. That such type of request for abroad visit was never refused to her earlier.
3. That she has never visited any foreign country earlier.
4. The expenses of her proposed foreign trip would be borne by her from her saving account no. 54058813860, having balance of Rs. 3,34,580/- as on 18.04.2022. Estimated expenses of the foreign trip is Rs. 1,34,000.00 (copy of passbook/ statement can be seen as attachment).

She has also attached her passport and invitation from the university, which also can be seen as attachments. She has, therefore requested for grant of permission to visit Paris and England (Europe) to attend the Convocation ceremony of her real sister Ms. Vineeta Giri, from 12.06.2022 to 19.06.2022.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sushri Preeti Giri. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Paris and England to attend the Convocation ceremony of her real sister Ms. Vineeta Giri to accompany her on her special moment in summer vacation from 12.06.2022 to 19.06.2022, thus this trip appears to be a pleasure trip which falls during summer vacation, It is on the discretion of the Hon'ble High Court either to grant her permission or to pass any such order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Vide subsequent order dated 19.10.2020, Hon'ble the Chief Justice has been pleased to nominate Hon'ble Mr. Justice Pritinker Diwaker, to consider request of permission of the Judicial Officers to visit abroad in his place.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Amroha for kind perusal and if His Lordship approves, Sushri Preeti Giri, Civil Judge (Junior Division), Amroha may be granted permission to visit Paris and England (Europe) to attend the Convocation ceremony of her real sister Ms. Vineeta Giri, from 12.06.2022 to 19.06.2022, as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/

Admin (A)/ dated 27.05.2017 and order dated 19.10.2020 of Hon'ble the Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
