May Kindly see the online application of Smt. Vandana, Civil Judge (Junior Division), Vidhuna-Auraiya by which she has requested for grant of permission to appear in Paper-1 (MCQ) examination for the post of Senior Personal Assistant at Pay Level 7 in Gargi College, University of Delhi.

In her application, Smt. Vandana has stated that Gargi College, University of Delhi has invited online applications for different permanent Non-Teaching posts in the pay scale with allowances permissible under the University rules vide its Recruitment Advertisement bearing Ref. No.: AC/Advt (NT)/2022/01 dated 17.03.2022 (Copy of advertisement can be seen as attachment). She has also stated that she is willing to apply for the post of Senior Personal Assistant at Pay Level 7 in Gargi College, University of Delhi as she possess all eligibility conditions for the said post. As per clause no. 07 of General Instructions for the applicants of Recruitment Advertisement, it is mentioned that "Those who are in employment with State/Central Govt/PSU, must upload a "NO OBJECTION CERTIFICATE" from the employer at the time of filling of application form before the due date. Failure to submit' NOC' by due date would lead to cancellation of candidature, thus she has requested for grant of permission and 'NOC' for aforesaid examination. Thereafter, through online objections, the officer was informed that 'No Objection Certificate' from the Hon'ble Court is issued at the level of interview and also asked to intimate the stages of selection and date of papers. In reply, the officer has stated that she has filled online application form for the post of Senior Personal Assistant in Gargi College on last date in anticipation of permission from the Hon'ble Court (Copy of online application form can be seen as attachment). Furthermore, as per Delhi University Recruitment Rules 2020, stage of selection for the post of Sr. P.A. are Paper-1 MCQ ; Paper-2 Descriptive Type & Paper -3 Skill Test (Qualification can also be seen as attachment) and the date of examination of paper-I has not been yet notified by the college. She has, therefore, requested for grant of permission for appearing in Paper-I of the aforesaid examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 04.07.2018. It is also pertinent to mention here that the officer has also requested to grant her 'No Objection Certificate' for the said exam, but it is to submit here that from this Hon'ble Court 'No Objection Certificate' is issued at the time of interview/ viva-voce only. It is desirable that she may be accorded permission to appear in the examination of Paper-I (MCQ) for the post of Senior Personal Assistant at Pay Level 7 in Gargi College, University of Delhi, at present, if the Hon'ble Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.

2. No preferential treatment will be given in the matter of leave, postings and transfer.

3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Auraiya for Her Lordship's kind perusal and orders to the effect that permission be accorded to Smt. Vandana, Civil Judge (Junior Division), Vidhuna-Auraiya to appear in the examination of Paper-I (MCQ) for the post of Senior Personal Assistant in Gargi College, University of Delhi, as requested, subject to the conditions mentioned above?
