Rest amount of Rs. 1,29,817 is stated to have been paid from his salary saving bank account, out of which Rs. 50,000/stated to be paid as advance booking amount and Rs. 45,000/- regarding car service plan, Rs. 20,000/- through cash to car dealer and Rs. 14,737 stated to be paid against TCS (Tax Collection at Source) (relating debit and credit entries can be seen in his passbook under attachment 'Bank Statement'). The dealer from whom the said cars has been purchased and sold by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Bahraich, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
