May kindly see the online application of Sri Nitin Kumar Rathi, Civil Judge (Junior Division), Iglas-Aligarh who joined service on 25.02.2020, drawing gross salary of Rs. 84,088/- & take home salary of Rs. 78,788/- regarding information about purchase of a new Toyota Urban Cruiser car, allotted reg. no. DL 10CP 8659, intimated through application dated 01.01.2023.

Through his application, Sri Nitin Kumar Rathi has submitted information about purchase of a new car on 30.03.2021 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Galaxy Automobiles Pvt. Ltd., 1A, Najafgarh Road, Moti Nagar, Delhi for Rs. 13,00,000/- (copy of invoice can be seen as attachment), source of money of which is that the total price of the car is stated to have been paid by his spouse Smt. Anita Yadav out of her S.B. A/c in various installments (Rs. 50,000/- Rs. 4,99,000/- Rs. 2,00,000/- Rs. 4,97,000/- & Rs. 54,046/-) (copy of statement of A/c of his wife can be seen as attachment). It is pertinent to mention here that his spouse is working as an Advocate after being enrolled in Bar council of Delhi in the year 2015 and practising in Delhi High Court. She has also been working in Supreme Court of India since 2019. Thus, the payment for car has been made from two premature fixed deposits mentioned as repayment credit from fixed deposit no 015100PU00012809 of Rs 6,07,355/- and fixed deposit no 015100PU00012809 of Rs 6,71,207/-. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Aligarh for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
