Thus, the payment for car has been made from two premature fixed deposits mentioned as repayment credit from fixed deposit no 015100PU00012809 of Rs 6,07,355/- and fixed deposit no 015100PU00012809 of Rs 6,71,207/-. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.
