May kindly see the online application of Smt. Lovely Jaiswal, Civil Judge (Senior Division), Hapur for grant of permission to sell her old Mahindra Xylo E4 car.

In her letter, Smt. Lovely Jaiswal has stated that she is the owner of an old Mahindra Xylo E4 car, having Registration No. UP 52W 6623 (Copy of RC can be seen as attachment) & now she wants to sell the same to Sri Rohit Kumar S/o Sri Mahinder Singh, R/o Gali No. 12, Vaishali Colony, Hapur City, Hapur for Rs. 1,50,000/-. The proposed purchaser is neither related to her in any way nor any of his case is pending or ever decided in her court. She has, therefore, requested that the Hon'ble Court may be pleased for grant of permission for sale of car to the proposed purchaser.

In this connection, it is submitted that the aforementioned car is stated to have been purchased by the officer in the year 2012 (intimation has been duly submitted by the officer). The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

"A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur/ Hon'ble Nominated Judge for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the district Hapur, for Her Lordship's kind perusal and, if Her Lordship approves, Smt. Lovely Jaiswal, Civil Judge (Senior Division), Hapur be granted permission to sell her old Mahindra Xylo E4 car, having reg. No. UP 52W 6623 to Sri Rohit Kumar S/o Sri Mahinder Singh, R/o Gali No. 12, Vaishali Colony, Hapur City, Hapur for Rs. 1,50,000/- (One lac fifty thousand rupees), as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
