May kindly see the online requisition dated 02.05.2022 of Sri Swapna Anand, Presently posted as, Civil Judge(Sr. Division), Ghazipur requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 20952022. In view of the above, Sri Swapna Anand has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification as well as an application for inclusion, as supporting documents which are required for the same.

Meanwhile, several objections, dated 05.05.2022, 22.05.2022 &19.10.2022, were raised by the office of this court and further, in reply, Sri Swapna Anand, Civil Judge(Sr. Division), Ghazipur, has duly furnished the required documents by attachment dated 21.10.2022 for the purpose of inclusion of the said Degree.

In the connection with the above, it is submitted that Sri Swapna Anand , joined the U.P. Judicial Service on 03.08.2013, initially as Additional Civil Judge (Junior Division), Pratapgarh. Further, it is relevant to mention here that Sri Swapna Anand pursued his LL.M. degree course from Distance Learning Education from Kurukshetra University after duly taking permission from the office of the High Court vide Court's letter no. 8437/IV-4018/Admin A-4 dated 29.06.2019 for the academic session 2018-2019, as per the records. In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sri Swapna Anand , completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Haryana on 31.08.2022, thus, the said qualification may be included in his service records as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Swapna Anand, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 02.05.2022 of Sri Swapna Anand, Civil Judge(Sr. Division), Ghazipur, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Ghazipur, for his Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Swapna Anand, Presently posted as , Civil Judge(Sr. Division), Ghazipur , may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
