May kindly see the online application of Sri Parvinder Singh, Additional Civil Judge (Senior Division), Deoband-Saharanpur by which he has requested for grant of permission to purchase a firearm.

In his application, Sri Parvinder Singh has stated that eariler he has applied for permission to apply for Arms license and to purchase fire arm but from the Hon'ble Court he was asked to get Arms license first and then apply for permission to purchase firearm. Then with prior permission, he has withdrawn his application (case id- S00000242019). Now, he has been issued Arms license by D.M. Sirsa, Haryana on 22.04.2022 (copy of the same can be seen as attachment). He has also stated that his hometown is Sirsa, Haryana and he has to travel alone for long distance. As no personal security is provided to Judicial officers and number of criminals appear in Court and he has family enmity in his hometown, therefore, he feel lack of security. He has also stated that many times Judicial officers has been attacked personally and for personal safety and freedom to do Judicial work independently, he is in urgent need to purchase firearm. He has added that he is purchasing Gun from Amit armoury Sirsa, Haryana and the Gun price is approximately 4500/- rupees only and he would pay price of gun from his salary account through cheque (copy of statement can be seen a attachment, showing balance amount of Rs. 50,692/-). He has, therefore, requested to kindly place his application before the Hon'ble Court for grant of permission to purchase the aforementioned firearm.

In this connection, it is submitted that according to this Court's C.L. no. 11/ IV-h-16/ Admin (A) dated 12.04.2010, the officer is required to take permission of the Hon'ble High Court to purchase firearm, for which he has requested. His request is considerable, as he has submitted sufficient details of the proposed transaction. It is also pertinent to mention here that as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Saharanpur, for His Lordship's kind perusal and if His Lordship approves, Sri Parvinder Singh, Additional Civil Judge (Senior Division), Deoband-Saharanpur be granted permission to purchase a Gun from Amit armoury Sirsa, Haryana , for Rs. 4500/- as requested, subject to the conditions that relevant papers of purchase transaction be submitted by him immediately after its completion?
