May kindly see the online application of Sri Syed Sarwar Husain Rizvi, Principal Judge, Family Court, Rampur regarding grant of permission to visit Iraq alone to visit some religious places in the month of June 2022 during recess tentatively from 11.06.2022 onwards for a period of about one week.

In his application, Sri Syed Sarwar Husain Rizvi has stated that he wants to visit Iraq alone to visit some religious places in the month of June 2022 during recess tentatively w.e.f. 11.06.2022 onwards for a period of about one week and the expenses to be incurred for the above visit is around one lac, which would be spent from his salary-savings. He has also enclosed copy of his passport and bank account passbook (showing balance amount of Rs. 8,70,384/-), which can be seen as attachment. He has also submitted the following declarations:-

- 1. That by his abroad visit no dilemma is likely to create before Government of India or Government of U.P..
- 2. That such type of request for abroad visit has not been refused earlier.
- 3. That he has never visited any foreign country earlier.

He has, therefore requested for grant of permission to visit Iraq for the aforesaid period.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sri Syed Sarwar Husain Rizvi. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities, the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Iraq in summer vacation/ recess for religious tour from 11.06.2022 onwards for a period of about one week, this trip appears to be a religious trip which falls during summer vacation. Now, It is on the discretion of the Hon'ble High Court either to grant him permission or to pass any such order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the Judicial Officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Vide subsequent order dated 19.10.2020 and thereafter vide order dated 29.03.2022 relating to constitution of Committees of Hon'ble Judges, Hon'ble The Chief Justice has been pleased to nominate Hon'ble Mr. Justice Pritinker Diwaker, Senior Judge (J-1) to consider matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Rampur for kind perusal and if His Lordship approves, Sri Syed Sarwar Husain Rizvi, Principal Judge, Family Court, Rampur may be granted permission to visit Iraq alone to visit some religious places there in the month of June 2022 during summer vacation/ recess tentatively from 11.06.2022 for a period of about one week, as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Senior Judge (J-1), as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, order dated 19.10.2020 and, order dated 29.03.2022 of Hon'ble The Chief Justice relating to the constitution of Committees of Hon'ble Judges, as mentioned above, with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
