She has also submitted the same separate application as an individual applicant judicial officer, which has also been processed and submitted onwards on Case Id : S00021952022 for orders, in which she has stated that for the purpose, her mother, a govt pensioner, is also wishing to gift her Rs Ten Lacs for her first home and also submitted Consent letter and account balance summary of her mother.</p>

It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956:-

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Subhash Vidhyarthi, Administrative Judge, Ramabai Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct rules 1956" for the district Ramabai Nagar, for His Lordship's kind perusal and if His Lordship approves, Sri Amarjeet, Additional District & Sessions Judge, Ramabai Nagar (Kanpur Dehat) may be granted permission to purchase plot No. G-46, Ekanki Enclave, Sector Pi-I, Greater Noida, measuring 558.60 Sq. metre, from four co-owners namely Mrs. Padmini Brahma W/o Mr. Pranjal Brahma, Mrs. Abhayeshwari Brahma W/o Mr. Ajay Brahma, Mrs. Renu Singh W/o Mr. Ajit Singh and Mrs. Beenapani Basumatari W/o Mr. Rabin Basumatari, all residents of-88 Janpath New Delhi for Rs. 1,70,00,000/- (One Crore & Seventy Lakhs rupees), jointly with his wife Smt. Sonica Choudhary, as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?
