May kindly see the online application of Sri Kanishk Kumar Singh, Additional District & Sessions Judge (FTC), Ramabai Nagar for grant of permission to sell his old Volkswagen Vento Diesel engine car.

In his letter, Sri Kanishk Kumar Singh has stated that he intends to sell his old Volkswagen Vento Diesel engine car having reg. no. DL3CBV0666 through dealership in Delhi. His car is 2012 make Volkswagen Vento Diesel engine. As per the NGT directions diesel vehicles which are more than 10 years old are not allowed to operate & thus he wants to sell the same to one Sri Rajkumar Mishra, 16/24 Civil Lies, Kanpur Road for Rs. 1,50,000/- (Copy of RC can be seen as attachment). The proposed purchaser is neither related to him in any way nor any of his case is pending in his court. He has, therefore, requested that the Hon'ble Court may be pleased for grant of permission for sale of car to the proposed purchaser.

In this connection, it is submitted that the aforementioned car is stated to have been purchased by the officer in the year 2012 i.e. before joining of judicial service. The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

"A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the district Ramabai Nagar, for His Lordship's kind perusal and, if His Lordship approves, Sri Kanishk Kumar Singh, Additional District & Sessions Judge (FTC), Ramabai Nagar be granted permission to sell his old Volkswagen Vento Diesel engine car, having reg. No. DL3CBV0666 to Sri Rajkumar Mishra, 16/24 Civil Lies, Kanpur Road for Rs. 1,50,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
