May kindly see the online application of Smt. Manisha, the then Spl. Judge (SC/ST, Pev. of Atroci Act), Ballia, presently suspended since 25.05.2023 (attached to Etah HQ) regarding issuance of 'No Objection/ Identity Certificate' for obtaining Passport.

In her application, Smt. Manisha has stated that she wishes to apply for a new Passport, which may be required for visiting foreign countries in future and for obtaining the same 'No Objection/ Identity Certificate' from the Hon'ble Court is required. Ms. Amrashaa Singh and Ms. Archisha Singh (Daughters) are dependent family members of the officer. She has also enclosed required details/ declaration on 'Affidavit', which may kindly be seen as attachment. She has, therefore requested to place her application before the Hon'ble Court for issuance of 'No Objection/ Identity Certificate' in her favour for obtaining Passport

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999. Here, it is further to be submitted that again as asked by Ld. Registrar (J) (B) fresh reports from concerned section(s) regarding present status of Inquiry has been asked and as per latest report dated 23.07.2024 of P.A. to Special Officer (Vigilance) section, a V.B. Inquiry No. 01 of 2022 has been initiated against Smt. Manisha, the then Additional District & Sessions Judge, Aligarh in which, inquiry report has been submitted to Hon'ble The Chief Justice on 14.02.2022. The matter was considered in Hon'ble Administrative Committee meeting dated 25.05.2023, wherein it is resolved to initiate a regular departmental inquiry against the officer (as mentioned in the copy of minutes of the Hon'ble A.C. Meeting dated 25.05.2023) and also resolved that the officer is to be placed under suspension forthwith with Headquarters at Etah and usual subsistence allowance be paid to her during the period of suspension. Moreover, in the report of Confidential (A) section dated 23.07.2024, it is stated that as per records presently available, D.E. No. 03/2023/ Cf(A) is pending against the officer. According to the Para 5 (1) of G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999, if any disciplinary proceeding is pending against a government servant, decision will have to be taken by the competent authority, for grant of permission of personal foreign visit to the government servant, seeing all the facts, and as per Note mentioned on 4th page of the aforesaid G.O. dated 14.06.1999, same process has to be adopted in the matter of issuance of 'No Objection Certificate', now called as 'Identity Certificate' in favour of a government servant for obtaining Passport. In the instant case, as there was earlier a V.B Inquiry has been initiated, which has been resolved to be a Departmental enquiry; is pending against Smt. Manisha presently suspended since 25.05.2023 (attached to Etah HQ), the matter for issuance of 'Identity Certificate' in favour of the officer for obtaining Passport, is on the discretion of Hon'ble the Administrative Judge, Etah, who is the competent authority in this matter.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah for His Lordship's kind perusal and if His Lordship approves:-

1. 'Identity Certificate' be issued, in duplicate, under the signature of Registrar (Judicial) (Budget) in favour of Smt. Manisha, the then Spl. Judge (SC/ST, Pev. of Atroci Act), Ballia presently suspended since 25.05.2023 (attached to Etah HQ), as requested, for obtaining Passport with the direction of the Hon'ble Court that she should take prior permission of the Hon'ble Court before proceeding abroad?

Or

2. 'Identity Certificate' be not issued, in favour of Smt. Manisha, Spl. Judge (SC/ST, Pev. of Atroci Act), Ballia presently suspended since 25.05.2023 (attached to Etah HQ) for obtaining Passport as a D.E. no. 03/2023/ Cf (A) is pending against her?

Or

3. To pass any other order, which His Lordship deems fit & proper.
