May kindly see the online application dated 11.07.2022 of Dr. Vidushi Singh, Principal Judge, Family Court, Mathura regarding grant of permission to use staff car for undertaking personal journey from Mathura to Ghaziabad on 17.07.2022 for some urgent work.

In her application, Dr. Vidushi Singh has stated that she wants to go to Ghaziabad for some urgent work on 17.07.2022. The distance of Ghaziabad from District Mathura is about 158 km. To undertake this journey, she desires to use official vehicle no. UP 70 AJ 2010. She will pay the expenses as per rule for use of official vehicle. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. Thereafter, she was asked to intimate as to whether she had performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then intimate about the amount paid. As intimated later by her, it is submitted that she has accomplished her journey on 17.07.2022 from Mathura to Ghaziabad in official car bearing reg. no. UP 70 AJ 2010, travelled 436 kms. and has paid an amount of Rs. 708/- by challan No. 0700/01/GJ00016 on 19.07.2022 which has been deposited in SBI, Mathura. Copy of Challan can be seen as attachment. She has, therefore, requested that Hon'ble Court may kindly be moved to accord her permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She has used the official vehicle for her personal journey from Mathura to Ghaziabad and has deposited due money, the same is in accordance with the relevant G.O. As such, her request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal & if His Lordship's approves, Dr. Vidushi Singh, Principal Judge, Family Court, Mathura be granted ex-post facto permission to use official vehicle no. UP 70 AJ 2010 for her personal journey to Ghaziabad on 17.07.2022 as mentioned above, as per the provisions of relevant G.O.?
