May kindly see the online application dated 28.07.2022 of Dr. Deepak Swaroop Saxena, Principal Judge, Family Court, Bulandshahar regarding grant of permission to use staff car for undertaking personal journey from Headquarter to Ghaziabad on 31.07.2022 for some work.

In his application, Dr. Deepak Swaroop Saxena has stated that he wants to go to Ghaziabad for some work on 31.07.2022. The distance of Ghaziabad from District Headquarter Bulandshahar is 56 km. He wants to use official car bearing registration No. UP 70 AG 2001 for this journey. He will pay the charges as per rule. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. Thereafter, he was asked to intimate as to whether he had performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey on 31.07.2022 from Headquarter to Ghaziabad in official car bearing reg. no. UP 70 AG 2001, travelled 172 kms. and has paid an amount of Rs. 516/- by challan No. HI00044 on 01.08.2022 which has been deposited in SBI, Bulandshahar. Copy of Challan can be seen as attachment. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. He has used the official vehicle for his personal journey from Headquarter to Ghaziabad and has deposited due money, the same is in accordance with the relevant G.O. As such, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal & if His Lordship approves, Dr. Deepak Swaroop Saxena, Principal Judge, Family Court, Bulandshahar be granted ex-post facto permission to use official vehicle no. UP 70 AG 2001 for his personal journey to Ghaziabad on 31.07.2022 as mentioned above, as per the provisions of relevant G.O.?
