May kindly see the online requisition dated 29.09.2022 of Sri Siddi Jai Prakash, posted as Nyayadhikari, Gram Nyayalaya, Dhanaura, Amroha, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 23412022. In view of the above, Sri Siddi Jai Prakash, has furnished his duly attested scanned copies of LL.M. Mark-sheets of all semesters and of the Degree Qualification, as supporting documents for the same.

Meanwhile, objection dated 05.04.2023 was raised by the office of this court and in reply, Sri Siddi Jai Prakash, aforesaid, has duly furnished the required documents & clarification by attachments dated 07.04.2023 for the purpose of inclusion of the said Degree.

In connection with the above, it is submitted that Sri Siddi Jai Prakash, joined the U.P. Judicial Service on 19.11.2019, initially as Additional Civil Judge(Junior Division), Amroha. Further, it is relevant to mention here that Sri Siddi Jai Prakash pursued his LL.M. three-year degree course from University of Delhi, Delhi in the year 2018-2021, after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service as per the records.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheets (all six semestesrs) and the copy of Degree Qualification, Sri Siddi Jai Prakash, completed her three-year LL.M. degree course in the year 2021 and was subsequently awarded the LL.M. Degree from University of Delhi, Delhi, on 26.02.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Siddi Jai Prakash, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 29.09.2022 of Sri Siddi Jai Prakash, Nyayadhikari, Gram Nyayalaya, Dhanaura, Amroha, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Krishan Pahal, Administrative Judge, Amroha, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (all six semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Siddi Jai Prakash, Nyayadhikari, Gram Nyayalaya, Dhanaura, Amroha, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
