May kindly see the online application of Sri Vikas Srivastava, Additional District & Sessions Judge, Allahabad for grant of permission to sell his old Indigo CS ELX 1.4L car.

Moreover, after its sale, he intends to purchase a new one. The said car is proposed to be sold to Sri Kuldeep Bhatnagar S/o Late Devkinandan Bhatnagar R/o 1A/12 Rampriya road P.O. Colonelganj, Tehsil Sadar, Distt. Prayagraj for Rs. 90,000/- (Copy of RC can be seen as attachment). The proposed purchaser is neither related to him in any way nor any of his case is pending in his court. He has, therefore, requested that the Hon'ble Court may be pleased for grant of permission for sale of car to the proposed purchaser.

In this connection, it is submitted that the aforementioned car is stated to have been purchased by the officer in the year 2011 i.e. before joining of judicial service. The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

"A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad, also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the district Allahabad, for His Lordship's kind perusal and, if His Lordship approves, Sri Vikas Srivastava, Additional District & Sessions Judge, Allahabad be granted permission to sell his old Indigo CS ELX 1.4L car, having reg. No. UP65 AY3197 to Sri Kuldeep Bhatnagar S/o Late Devkinandan Bhatnagar R/o 1A/12 Rampriya road P.O. Colonelganj, Tehsil Sadar, Distt. Prayagraj for Rs. 90,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
