May Kindly see the online application of Sushri Pooja Suhag, Judicial Magistrate, Baghpat by which she has requested for grant of permission for appearing in the interview of Haryana Civil Services (Judicial Branch) Examination, 2020-21.

In her application, Sushri Pooja Suhag has stated that she has already taken permission for appearing in Haryana Judiciary examination whose preliminary exam was held on 13th November 2021 and she got selected in that examination after which she has appeared in the mains examination of the same, held on 20th ,21st ,22nd May 2022 and the result of Mains examination has been declared on 3rd August 2022 in which she has declared successful. She has also stated that she has appeared in Mains examination in the anticipation of required permission which is currently pending at the level of Hon'ble Judge and she is now being called for interview of the same examination; scheduled on 11th September 2022 and her roll no. for the same is 2679 She has therefore requested for grant of permission to appear in the said interview. Thereafter, through online objection, the officer was asked to submit her interview call letter and also Hon'ble Court's letter through which she has been granted preliminary exam permission. In reply, the officer has uploaded the required papers, which can be seen as attachments. She has, therefore, requested to Hon'ble Court to grant her permission to appear in the interview of Haryana Civil Services (Judicial Branch) Examination-2020-21.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 18.11.2019. Earlier, the officer had been granted permission for appearing in the Prelims examination of Haryana Civil Services (Judicial Branch) examination 2020-21 vide order dated 20.03.2021 of Hon'ble the Administrative Judge, Baghpat. It is also pertinent to mention here that the officer has requested for grant of permission for appearing in the Mains exam of the same through online old case Id. 1832, upon which detailed office note has been prepared and the same is now at the level of Hon'ble Administrative Judge, Baghpat. In the meanwhile, the officer has appeared in the stated Mains examination in anticipation of Hon'ble Court's permission and also passed the same. It is further to mention here that the officer has requested for grant of permission for appearing in the interview of said examination but at the level of interview/ viva voce. 'No Objection Certificate' is issued from this Hon'ble Court. Now, It is upto the discretion of Hon'ble Court to grant her permission for appearing in the interview of the same and also issue 'No Objection Certificate' in her favour or to pass any other order.

May, therefore, if approved, the file kindly be laid before Hon'ble Mr. Justice Mohd. Aslam, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal & if His Lordship approves 'No Objection Certificate' be issued, offline, in duplicate, under the signature of I/c Joint Registrar (Judicial) Budget in favour of Sushri Pooja Suhag, Judicial Magistrate, Baghpat for appearing in the interview of Haryana Civil Services (Judicial Branch) examination 2020-21, as requested?
