It is also noteworthy to mention here that normally such type of matters are submitted to Hon'ble the Administrative Judge of concerned District but as the officer is posted in this Hon'ble Court as Registrar (J) (Criminal), High Court, Allahabad, (Prayagraj) and as per resolution passed in the meeting of the Hon'ble Administrative Committee held on 12.07.2013, he is under the exclusive control of the Hon'ble The Chief Justice and as such the matter is likely to be placed before Hon'ble The Chief Justice.

Under the facts & details mentioned above and as the officer has purchased the plot from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble The Chief Justice for His Lordship's kind perusal and information under rule 24(1) of U.P. Government Servant's Conduct Rules, 1956?
