May kindly see the online requisition dated 02.09.2022 of Sri Sanjai Veer Singh, Presently posted as , Additional District and Sessions Judge, Amroha, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 24172022. In view of the above, Sri Sanjai Veer Singh has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

In the connection with the above, it is submitted that Sri Sanjai Veer Singh, joined the U.P. Judicial Service on 11.09.2015, initially as Additional District and Sessions Judge, Aligarh. Further, it is relevant to mention here that Sri Sanjai Veer Singh , pursued his LL.M. course from Distance Learning Education from Kurukshetra University after duly taking permission from the office of the High Court vide Court's letter no. 16897/IV-4199/Admin A-4 dated 24.11.2018 for the academic session starting 2017-2018.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sri Sanjai Veer Singh, completed his two-year LL.M. degree course in the year 2020 and was subsequently awarded Degree from Kurukshetra University, Haryana on 30.09.2021, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Sanjai Veer Singh , aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 02.09.2022 of Sri Sanjai Veer Singh Additional District and Sessions Judge, Amroha, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Krishan Pahal, Administrative Judge, Amroha for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Sanjai Veer Singh, Additional District and Sessions Judge, Amroha, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter, without entering into the fact that the University is recognised by Uninversity Grants Commission or not and without reserving any future claim of the officer regarding his qualification, if the University is not recognised for LL.M Degree Qualification.
