May kindly see the online requisition dated 09.09.2022 (received online) of Sri Satyendra Kumar Chaudhary, Additional Chief Judicial Magistrate, Mainpuri, requesting for inclusion of his Ph.D. Degree in his service records & addition of prefixing the word "Doctor" in his name vide Case Id. No. 24332022. In view of the above, Sri Satyendra Kumar Chaudhary, has furnished his duly attested scanned copies of the Degree Qualification, as supporting document for the same.

An objection dated 10.10.2022 was raised by this office and in reply, Sri Satyendra Kumar Chaudhary, aforesaid has furnished the desired document by attachment dated 18.02.2023.

In this connection, it is submitted that Sri Satyendra Kumar Chaudhary, aforesaid, joined U.P. Judicial Service on 03.03.2017 as Additional Civil Judge (Junior Division), Sitapur. Besides, as evident from his submitted attested copy of his degree of Ph.D., Sri Satyendra Kumar Chaudhary, aforesaid, completed his Doctor of Philosophy (Ph.D.) course in the department of Law for the topic "Socio-Legal Dimensions of Euthansia: A Comparative Study" in the year 2022 from the University of Lucknow, Lucknow and was subsequently awarded the Ph.D. Degree on 21.01.2023, after duly taking permission from this Hon'ble court through online portal regarding submission of Ph.D. Thesis, in the middle of the course, after Joining the Judicial Service. The copy of permission so obtained, has been submitted herewith on attachment dated 09-09-2022.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus said qualification of Ph.D. Degree may be included in his service-records & prefixing word "Doctor" be added in the name of Sri Satyendra Kumar Chaudhary, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 09.09.2022 (received online) of Sri Satyendra Kumar Chaudhary, Additional Chief Judicial Magistrate, Mainpuri, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Vipin Chandra Dixit Administrative Judge, Mainpuri, for His Lordship's kind perusal and approval to the effect that copy of aforesaid letter dated 09.09.2022 (received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Satyendra Kumar Chaudhary, Additional Chief Judicial Magistrate, Mainpuri, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
