May kindly see the online application dated 23.09.2022 of Smt. Pooja Singh, Additional District & Sessions Judge, Gonda regarding grant of permission to use staff car for some important personal work from Gonda to Faizabad on 23.09.2022 after court hours.

In her application, Smt. Pooja Singh has stated that she wants to go to Faizabad for some important personal work on 23.09.2022 after court hours. The distance of Faizabad from Gonda is about 140 kms. She wants to use official car bearing registration no. UP 43 G 0233 for the journey and will pay the charges as per rule. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid personal journey. It has been further asked from the officer that whether she has performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms then to intimate about the amount paid. As intimated later by her, it is submitted that she has accomplished her journey from Gonda to Faizabad in official car bearing reg. no. UP 43 G 0233. It has also been asked from the officer that she applies for this type of permission just on the same day of journey or just a day before and performs the journey without the grant of permission/ during pendency of her application, to use official vehicle for personal use. She has also been asked to clarify about the point mentioned above, so that the matter may be placed before the Hon'ble Court with certain required details. She is also to submit chart of journeys performed more than one time in a month showing details excluding the permissible limit of 200 kms. for personal use of the vehicle, in any such application(s) which falls in same month. Thus, It is expected that she will apply for this type of permission well in advance, so that the matter may be considered for grant of prior permission in this regard by this Hon'ble Court. In reply of the above query, the officer has stated that she has performed the said journey in anticipation of permission due to an urgent need & has travelled total distance of 320 Kms. in which 120 Km exceeds from the permissible limit 200 Km. Thus, she has paid Rs. 360/- for excess distance travelled by her through Challan Receipt No. K200019. Copy of Challan can be seen as attachment. Thus, according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are authorized to use official vehicle for 200 kms for personal use of the staff car & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She has used the official vehicle for her personal journey from Gonda to Faizabad and has deposited due money, the same is in accordance with the relevant G.O. As such, her request to use official vehicle appears to be considerable. She has, therefore, requested that Hon'ble Court may kindly be moved to accord her permission for use of the official vehicle for the above mentioned visit.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official car bearing Registration No. UP 43 G 0233 by Smt. Pooja Singh, Additional District & Sessions Judge, Gonda for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
