May kindly peruse online request dated 27.09.2022 accompanied with resignation notice dated 27.09.2022 (**Annexure under heading Resignation Letter**) of Smt. Shreya Bhargava, Civil Judge(Senior Division), Raebareli, duly forwarded by the District Judge, Raebareli, whereby she has voluntarily and unconditionally tendered resignation from U.P.Judicial Service in light of Rule 4 contained in The Uttar Pradesh Government Servants' Resignation Rules, 2000 on account of her personal reasons.

Vide aforesaid resignation notice dated 27.09.2022 (**Annexure under heading Resignation Letter**), Smt. Shreya Bhargava has informed that she is the only child of her parents thus she has to take care of her mother as well as old and ailing in-laws. Besides, due to other unavoidable and pressing family needs, it is becoming tough for her to remain in service. Hence, she has desired to be relieved from U.P.Judicial Services w.e.f. 28.12.2022 , after expiry of notice period of three months.

In this context it is submitted that Smt. Shreya Bhargava entered into U.P.Nyayik Sewa as Additional Civil Judge (Junior Division), Jaunpur on 17.04.2015 and as per report dated 28.09.2022 obtained from Confidential 'B' section, she has been confirmed in U.P.Nyayik Sewa vide Court's Notification No. C-816/CF(B)/2021 dated 11.08.2021.

In this respect it is further submitted that resignation/relieving requests of confirmed officers are carried out in accordance with provisions contained in **Rule 4 of The Uttar Pradesh Government Servants' Resignation Rules, 2000** which provides as quoted here under :

4. Notice of Resignation :

(1) A Government servant may resign from his service by giving three months notice in writing.

(2) The notice of resignation shall be -

(i) voluntary and unconditional,

(ii) addressed to the appointing authority under intimation to the authority under whom the said Government servant is working at the time of tendering resignation :

Provided that it shall be open to the appointing authority to allow a Government servant to resign without any notice or by a shorter notice.

In instant matter, since the appointing authority is the Government of U.P, thus request regarding acceptance of resignation/relieving from service has to be sent to the Government of U.P. for necessary orders.

Further, as per reports (**obtained in offline mode and placed in Miscellaneous Records file of officer**) obtained from concerned departments, there is no departmental/vigilance enquiry pending against Smt. Shreya Bhargava, Civil Judge(Senior Division), Raebareli.

In the view of above submitted facts and information, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Pritinker Diwaker, Senior Judge (J-1), (Hon'ble Committee mentioned at Sl. No. 3 in Committee Reconstitution order dated 29.03.2022), for His Lordship's kind perusal and order to the effect that request dated 27.09.2022 accompanied with resignation notice dated 27.09.2022 (Annexure under heading Resignation Letter) and other enclosures of Smt. Shreya Bhargava, Civil Judge(Senior Division), Raebareli as well as aforesaid information about nature of her employment, notice period, relieving date, etc. may be sent to the Special Secretary, Appointment Section-4, Government of U.P, Lucknow with necessary recommendation of Hon'ble Court, for relieving of Smt. Shreya Bhargava, Civil Judge(Senior Division), Raebareli from U.P.Nyayik Sewa, in accordance with The Uttar Pradesh Government Servants' Resignation Rules, 2000 ?
